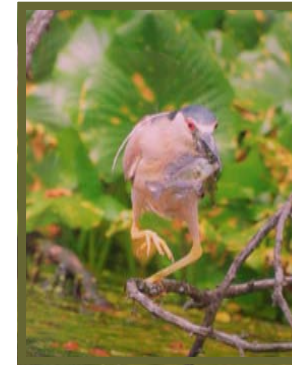

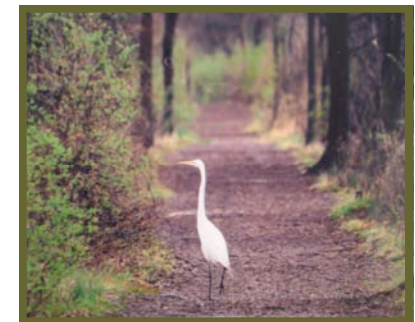

Contest Rules

PREPARING PHOTOS

- Only 2 submissions per person.
- Entries must be prints measuring no greater than 9" x 12".
- All prints must be mounted on white 11" x 14" mounting board or rigid art board.
- No frames are permitted.
- Entrants are responsible for securing and submitting a standard photo release from all identifiable persons.
- No marks or names that can identify the photographer may be visible on the front of the photograph or mat.
- A copy of the completed photo contest entry form must accompany each photo submitted. Please indicate the proper orientation of the photo to ensure that it can be hung properly.

RETURNS

- Entrants who want their materials returned must provide a self-addressed properly stamped envelope with the proper amount of postage (postage stamps only please) and appropriate packaging material to ensure safe delivery by the USPS — or — pick up their photographs at Olewine Nature Center on Friday, January 28, Saturday, January 29, or Sunday, January 30 from 1 to 4 pm.

- The Friends of Wildwood and the Dauphin County Department of Parks and Recreation reserve the right to publish or display submitted photographs on our website and other venues.
- The Friends of Wildwood assume no liability for any loss, damage or injury of any kind to persons or property resulting from participation in this contest.
